GUIDELINES FOR SHRI B. C. MAHESHWARI AND SMT. SUGAN DEVI MAHESHWARI MEMORIAL SCHOLARSHIPS

The Indian Society of Accounting & Management (INDSAM) offers Two Scholarships named as under:

- (i) Shri B.C. Maheshwari Memorial Scholarship (for Boys Only)
- (ii) Smt. Sujan Devi Maheshwari Memorial Scholarship (for Girls Only)


The amount of Scholarship is ₹ 5,000/- per semester for a university student and Rs. 10,000/- for a year for a CA Final Student.

The Scholarships would be conferred upon meritorious and economically weak students. The beneficiaries of the scholarship shall be selected from the applicants, by a Committee comprising of eminent persons. A total of **Two Students** (one girl & one boy) would be selected from B.Com. (Hons.)/BBA/MBA/Chartered Accountancy Course. The following criteria shall be used to select the candidates:

1. Students should have successfully completed their previous semester/year of B. Com (Hons.), BBA & MBA and CA Inter (as may be relevant) from a recognized University/ICAI and cleared in the First Attempt.
2. The applicant's Family Gross Income should not exceed ₹ 5,00,000 per annum.
3. Application shall be submitted by students seeking the scholarship on the prescribed format. The format requires accurate Academic and Financial Information from the applicant.
4. The Awards Committee follows a Graded Score System evaluating both academic and financial details of the applicant.
5. The Committee shall identify the student with the highest score for the concerned scholarship.
6. The selected candidate shall appear for an interview, if desired, with the Chairman of the Society, at the final stage.

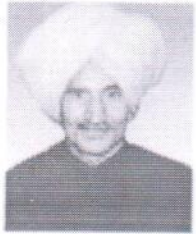

1. Annual Gross Income Certificate
 - (1) *Income Tax Assessee*: The latest Income Tax Assessment Order (not older than Two Assessment Years, preceding the last date of scholarship application submission).

Note: In case one of the parent of the applicant is an Income Tax Assessee, while the other parent has no income, an affidavit verified by the 1st Class Magistrate may be submitted stating that he or she does not have any income.
 - (2) *Non -Income Tax Assessee*:
 - (i) If employed:
 - (a) Annual Gross Salary Certificate from the Employer of Parent(s);
 - (b) An Affidavit duly attested by First Class Magistrate declaring Annual Gross Family Income from all sources.
 - (ii) If not employed:

Copy of the Gross Annual Family Income Certificate issued by the Area SDM or Other Officer Authorized in this behalf by the Revenue Department of the Government. The issued Income Certificate should be valid as per the Government Norms on the date of issue of the notice of Scholarship.
2. University/Institute of Chartered Accountants of India (ICAI) Enrolment Certificate.
3. Attested copies of the marksheets of class XII previous semester/year BBA/B. Com (Hons.)/MBA examination/CA Inter/ Graduation (as may be relevant).
4. Recommendation of Dean/Principal/Director of the concerned University School of Studies/Affiliated College or Employer (for students of ICAI).
5. Copy of receipt of last fee deposited in the University/College/ICAI.

Note:

- *The candidate who does not clear his examination (BBA/B. Com (Hons.)/MBA/ Previous Semester/Year / CA Inter (as may be relevant) in the first attempt will be ineligible for availing the scholarship.*
- *The completed application with requisite documents will be accepted upto 30th September & 31st March every year. Any application received after the given date, due to postal delay or any other reason, will not be considered.*
- *Incomplete application or application not in the prescribed form shall not be entertained.*
