Please provide the Final admission list of students (first year admission) indicating their category published by the HEI and signed by the principal in the justified manner, as to be countable, for the total number of the First year/ semester students, for the last five years. 7. Please provide approval of additional intake of students to support the claim. 8. Kindly note that the data for the metric id. 2.1.2.2. should be (according to the state reservation policy) of the data of the metric id. 2.1.1.2.
