ELIGIBILITY CRITERIA FOR CANDIDATE AS PER RECOMMENDATIONS OF LYNGDOCH COMMITTEE'S REPORT:

1. Under graduate student between the age 17 and 22 may contest election.
2. The candidate should in no event have any academic arrears in the year of contesting elections.
3. The Candidate shall have attained the minimum 75 percentage of attendance.
4. The candidate shall have one opportunity to contest for the post of office bearer.
5. The candidate shall not have a previous criminal record.
6. The candidate must be a regular, full time student of the college.
7. A written undertaking from candidates stating they and their supporters will not indulge in defacement, with the understanding that violations may lead to disqualification.

INSTRUCTIONS FOR CANDIDATES:

1. For the post of President, only Third and Fourth year students will be eligible to contest election.
2. For the post of Vice President, first year students will not be eligible to contest election.
3. For the post of Sports Secretary, candidates should have excellence in sports.
4. For the post of Course Representative, the proposer and seconder should be from the same course.
5. Proposer/Secunder cannot propose or second more than one candidate for the same post.
6. No Candidate will be allowed to cast his or her vote without identity Card.
7. No Election agent will be allowed to sit in the Counting Room without Identity Card.
8. Nomination Papers of the candidate will be rejected if he/she have not paid the fees by 18th September, 2025 (till 1.00 p.m.).
9. Every candidate will have to attach the photocopy of his/her fee receipt and identity card.
10. Attach the Marksheet of the last Examination/Semester Passed without an ER with the nomination form.
11. Proposer and Secunder² are required to attach photocopy of ID Card and Fee receipt.
12. Incorrect filling of name, class and roll number of the candidates, proposer or seconder (Not matching the college record) will also lead to rejection of the nomination paper.
13. No candidate shall indulge in, nor shall abet, any activity, which may aggravate existing differences or create mutual hatred or cause tension between different castes and communities, religious or linguistic, or between any group(s) of students.
14. Criticism of other candidates, when made, shall be confined to their policies and programs, past record and work. Candidates shall refrain from criticism of all aspects of private life, not connected with the public activities of the other candidates or supporters of such other candidates. Criticism of other candidates, or their supporters based on unverified allegations or distortion shall be avoided.
15. No candidate shall be permitted to make use of printed posters, printed pamphlets, or any other printed material for the purpose of canvassing.
16. No candidate shall, nor shall his/her supporters, deface or cause any destruction to any property of the university / college campus, for any purpose whatsoever, without the prior written permission of the college / university authorities. All candidates shall be held jointly and severally liable for any destruction / defacing of any university / college property.
17. Every candidate is subject to total disciplinary norms of the college and can be suspended immediately without notice if found indulging in violence or threatening any candidate / student of the college.
18. The maximum permitted expenditure per candidate shall be Rs. 5000/-
19. Posters and Play Cards should not be used in Campus during the Election Campaigns.
20. Any contravention of any of the above recommendations may make the candidate liable to be stripped of his candidature, or his elected post, as the case may be. The election commission / college authority may also take appropriate disciplinary action against such a violator.
