

In the Meeting held on the 12th of Aug, 2005 the Staff Council discussed the Agenda and the Minutes of the Meeting are as follows:

1. The different Committees were formed, a list of the same is attached herewith. Four new committees that were formed are the Sports Committee, the Land and Building Committee, the Monitoring Committee and Grievances Cell, and the Moderation Committee which will be formed in each department as per the Ordinance.
These Committees will function for two years i.e. 2005 – 2006 and 2006 – 2007.
2. The Students Union Elections for the year 2005 – 2006 will be held on 30th of August, 2005. The Schedule of the same will be worked out accordingly by the Principal and the Returning Officer, Mrs. Subodh Sharma (the Staff Union Advisor).
It was also decided unanimously that Mr. Shrikant Pandey would be the Staff Union Advisor for the new Students Union to be elected on 30th Aug., 2005.
3. Dr. Anita Bhela was unanimously elected the new Staff Council Secretary for the next two years i.e. 2005-2006 and 2006-2007.
4. The Principal informed the house that a letter had been given by Mrs. Nileema Bhardwaj, and signed by many others, regarding certain problems with the Journalism Course but he specified that the problems had been resolved and hence did not need to be brought up again.
5. Mrs. Meera Malhan raised the issue of the Sexual Harassment Committee and whether it was formed according to the ordinances. The Principal informed her that it was formed according to the ordinances and its term extends for one more year. Moreover this particular Committee does not fall in the putview of the Staff Council.
