- ✓ Self attested copy of latest ITR/Income certificate / Income statement/BPL card/ MNREGA card/ Labour card duly signed by the competent authority (issued on or after 1st April 2023)
- ✓ Self attested copy of cancelled cheque of the bank account in the name of the student/front page of the bank pass book in the student's name

Please note:

The fee concession form is to be downloaded from the college website and is to be submitted with **Mr. Ram Kanojia** in the Administrative Block of the college personally alongwith the documents.

Incomplete forms without required documentary evidence will not be considered.

Merely applying does not make you eligible for fee concession.

Decision of the fee concession committee will be final.

The Last date to apply form and documents is 27th December 2023.
