

This Memorandum of Understanding is made and entered into on 26th day of October 2021 between the parties as follows:

The Parties

The Delhi College of Arts and Commerce (a constituent college of University of Delhi) situated at Netaji Nagar, New Delhi-110023 represented through its Principal, Dr. Rajeev Chopra, (hereinafter referred as DCAC) which expression shall, unless excluded by or repugnant to the context, be deemed to include its administrators, executors, liquidators, successors in interest and permitted assigns of the First Part.

AND

Surbhi India Technology Pvt Ltd (under the brand name of Apar India), 795, Udyog Vihar Phase V, Phase V, Udyog Vihar, Sector 19, Gurugram, Haryana 122016 through its authorized representative, Mr.R.K. JAIN which expression shall, unless excluded by or repugnant to the context, be deemed to include its administrators, executors, liquidators, successors in interest and permitted assigns of the Second Part.

Whereas, both the parties are is desirous of introducing and offering Vocational Course under the Add on Courses of the college for the prospective learners/students seeking to learn the skills related to this sector an wishes to associate with Apar India as a knowledge partner to provide training and mobilization of students for Vocational Courses

And whereas, APAR INDIA possessing extensive teaching and education background of Vocational education field for more than 2 decades, is willing to partner with DCAC to impart the Vocational education, designed and developed by Apar India in the field of Media and entertainment, Information Technology, Management, Health and Fitness, in consultation with APAR INDIA.

And whereas both the parties have agreed upon to enter into this Memorandum of Understanding on the following terms and conditions:-

- The Apar India shall be responsible to impart the necessary education for the Vocational Courses of DCAC and classroom sessions in the premises of DCAC, to the students enrolled an admitted in various courses devised into relevant subject categories.
- 2. The DCAC shall provide necessary support staff(s), classrooms, computer lab and reception room etc. available in its premises with requisite furniture/electricity/fans/lights/ instructions boards to APAR INDIA for the aforesaid purpose of successfully delivery of the Various Courses of DCAC.
- 3. That Apar India shall collect the fee from students, issue fee receipts in original to students, maintain batch-wise and detailed record of students and collection other necessary records.Summary of such data shall be shared with the DCAC to facilitate smooth planning, execution and functioning of classes and educational training.

- 10. That DCAC shall also provide its computer lab and classroom along with power-backup and publicity spaces within its premises for the promotion of the course and teaching of any part/module/topic of the certificate course(s) by APAR INDIA at no extra costs.
- 11. APAR INDIA shall continue with its educational activities elsewhere also.
- 12. DCAC & APAR INDIA shall jointly determine the timings of the class.

- 13. That DCAC shall ensure the courses run by Apar India & the properties of Apar India in its premises are not effected in anyway by the activities of any students' or teachers' union operating in the vicinity.
- 14. The security guards/gate-keepers of DCAC shall be duly informed by DCAC to allow entry of the admitted candidates for the courses to be run through APAR INDIA.
- 15. That DCAC will enforce upon the students that no refund of fees already paid shall be entertained and also not permit / allow defaulting candidates to attend the classes.
- 16. That on successful completion of the program & its evaluation by Apar India or the DCAC, the DCAC will issue certificate(s) of the courses completed, jointly countersigned by the authorized person of Apar India. Likewise, the students' identity cards shall also be issued by DCAC at the time of the enrollment of the students.
- 17. That Apar India assures and undertakes that all the material which includes the software and study material used by Apar India for the purpose of running the course is not in violation of any Intellectual Property or any provision of the Information Technology Act. Apar India undertakes that in case of any such violation/infringement is detected or alleged; Apar India shall exclusive face the consequences of the same shall keep the college indemnified. - 7.1 Draw the attention of the top management in case of any interface or operational problems.

 - 8.5 For any intellectual property arising during the operation of this MoU, respective Participating Institutions intend to ensure adequate and effective protection of the same in order to maintain its uniqueness and shall never be shared with any outsider.

- 17.1 Any Notice, request, demand, approval, consent or other communications provided or permitted hereunder shall be in writing in Hindi/English Language and given by personal delivery or sent by registered post or by fax/email addressed to the above nodal contacts.
- 17.2 Notices delivered personally will be deemed communicated as of actual receipt. Mailed notices will be deemed communicated as of four (4) days after mailing.
- 17.3 Post-mailed notices will be deemed communicated as of seven (7) days after mailing.

18. MODIFICATION

18.1 No modification to this MoU, will be effective unless agreed to in writing by all the parties and duly signed by the authorised signatories of the Parties.

19. HEADING

19.1 The headings shall not limit, alter or affect the meaning of the Clauses headed by them and are solely for the purpose of easy reference.

Whereas the DCAC has agreed to provide DCAC College Ground on contract of 5 years to Talent Sports. Therefore, both the parties have agreed to reduce the terms and conditions into writing for the purpose of certainty and clarity, which witness as under:

DCAC College shall provide the required access to ground for Talent sports staff for maintenance and upkeep of the facility.

8. Talent sports will have exclusive right to use the Play Ground Daily between 3 p.m. to 7 pm. to run the coaching academy and such further time as may require as per needs. On College holidays or Sundays Talent sports can run the coaching academy from 7 a.m to 7 p.m.

✓ Prakriti – The Environmental Society


